

SITUATION

Philippe enjoyed his work as an aviation systems technician in the Royal Canadian Air Force. However, prolonged exposure to loud noises and the intricate and physically intensive nature of working on large aircraft took a toll on his body. Eventually, he found it difficult and painful to fulfill his duties. After releasing from the military, he worked with his case managers from both the Canadian Armed Forces and Veterans Affairs Canada (VAC) to establish physical and vocational rehabilitation plans.

BENEFITS AND SUPPORT

Through the Pain and Suffering Compensation, Philippe will receive a total value of \$381,700 (non-taxable) as recognition of his service-related pain and suffering. It will be paid monthly for life.

The Canadian Armed Forces Long Term Disability insurance program determined that Philippe was totally disabled at the time he was medically released. Later, VAC's separate assessment established that Philippe has a diminished earning capacity. Therefore, Philippe's income replacement and rehabilitation needs will be addressed through a partnership between CAF LTD and VAC until he reaches the age of 65. At that point, VAC will take full responsibility for delivering Philippe's programs and services.

To compensate for his loss of income Philippe will receive monthly income replacement payments during his rehabilitation period. Given VAC's assessment of his diminished earning capacity, the Income Replacement Benefit will continue for his lifetime up to a net of \$2.266M (after tax). When Phillipe starts receiving this benefit for life, his IRB will be increased by 1% every year to recognize lost career progression. He will be recognized for eight years of lost career progression. Once Philippe reaches the age of 65, the IRB will continue at a reduced rate.

As part of his rehabilitation, Philippe is working with his VAC physiotherapist and occupational therapist. Once he is finished his program, Philippe would like to keep active and stay engaged in his community. He is considering working part-time in his local garage a few days a week, as he can earn up to \$20,000 without reduction of his Income Replacement Benefit.
