Potential Events and Activities Minister of Veterans Affairs Canada October 2019

Context

The following is a proposed outreach plan for the Minister of Veterans Affairs post-election. Activities, dates and locations are subject to change based on the following considerations:

- Providing a variety of formats for connecting with diverse stakeholders and Veterans;
- Other events for engagement may be included at a later date;
- Where possible, including representation of different cities than the 2019 ministerial events; and
- Where possible, proposing events when the House of Commons is not sitting.

Political considerations may impact the calendar, including the political party that forms Government and the location of the riding of the new Minister. The calendar may shift to ensure the nature, scope and approach of engagement activities is reflective of the Minister's mandate commitments.

Field Operations has reviewed the proposed calendar and there were no particular area office events or items to note for consideration at this time. Commemoration has reviewed the calendar and has included updates based on their upcoming events.

As the National Stakeholder Summit is proposed to take place within the first 90 days of newly appointed Minister, it is recommended that roundtables and/or town halls take place post-National Summit.

A list of 2018 and 2019 roundtables, town halls, and forums that provided an opportunity for former Minister to engage with stakeholders is included as Annex A. The House of Commons Sitting Calendar is attached as Annex B.
